Kristianstads Teater ligger som en festlig krok mitt i Tivoliparken. Den invigdes i september 1906. Stilen går i vacker jugendbarock och är ritad av arkitekten Axel Anderberg, som även ritat Operan och Oscarsteatern i Stockholm.

Salongens inredning i rött, guld och grönt tillsammans med plafondmålningen av Nils Asplund är väl bevarad från tidens tand. Teatern är en av de äldsta i landet som är i bruk.

Nu planeras en uppfräschning av salongen och de gamla stolarna ska bytas ut. Sammanlagt handlar det om 84 st. nya stolar. Omfattningen gäller köp, leverans och montering av stolarna. Beräknad starttid 19.8.2013.

Brukaren kommer att riva befintliga stolar innan detta åtagande påbörjas på plats.
