Description: Jatkuvan oppimisen ja työllisyyden palvelukeskus (Jotpa) hankkii koulutusta, jonka tavoitteena on tukea aurinkoenergian rakentamista teollisessa mittakaavassa ja parantaa teollisten laitosten energiatehokkuutta. Tällä hankinnalla vastataan aurinkovoiman nopean kasvun luomiin osaamistarpeisiin. Hankinnalla tuetaan myös teollisia toimijoita kehittämään energiatehokkuuttaan sekä saavuttamaan tavoitteet, joita niille on asetettu sääntelyllä ja vapaaehtoisilla sopimuksilla. Hankintayksikkö voi keskeyttää hankintamenettelyn perustellusta ja todellisesta syystä (hankintalain 125 §). Tarjouksen tekemisestä, esittelystä tai muusta menettelyyn osallistumisesta ei makseta tarjoajille korvausta. Hankintapäätöksen jälkeen tarjouksen voittaneen palveluntuottajan tulee esittää yrityksen vastuullisessa asemassa olevien henkilöiden rikosrekisteriote ennen hankintasopimuksen tekemistä (Laki julkisista hankinnoista ja käyttöoikeussopimuksista 1397/2016).
