Reasons for the decision to award: In each case, the best fulfillment of the set requirements based on the result of the evaluation of all award criteria (Quality & price).
As described in the published tender documents (price sheets), the total value of the procurement quantity including options (5-year contract period plus 2 + 2-year options) for lot 1 (Tarnanzug & Arbeitsanzug Sommer) was determined by armasuisse. For this purpose, the option quantities announced in the tender documents were extrapolated with the average prices of the three awarded quantity lots. This calculated total value forms the maximum award sum for Lot 1 (Tarnanzug & Arbeitsanzug Sommer) and amounts to CHF 18'837'805.60 (excluding VAT).
