Additional information: According to the Public Procurement Regulations § 7-9 fifth paragraph, the obligation to set requirements or criteria on climate and environmental considerations in accordance with the mentioned provision does not apply "if the procurement, in accordance with nature, has a climate footprint and an environmental impact that is immaterial." The current procurement of a sub-contract for mentor services is a procurement that has, to a large degree, an immaterial climate footprint and environmental impact. This is justified by the fact that the sub-contract is for consultancy services, as well as restricted travel activities and the procurement of products. Sub-contract I only applies to the provision of services in the municipality's own premises, with the municipality's own equipment and with the municipality's

own vehicles. In other words, it is not possible for the tenderer to influence the environment in the provision of this service. The procurement is considered to have such a low environmental impact, that the exception in accordance with PPR § 7-9 fifth paragraph will apply. An award criteria will, therefore, not be set up or requirements related to climate and environmental considerations will be set. According to the Public Procurement Regulations § 7-9, "Award criteria in accordance with the second and third paragraphs can be replaced with climate and environmental requirements in the requirement specifications, if it is clear that this provides a better climate and environmental effect and this is justified in the procurement documents". Sub-contract II is also mainly for consultancy procurements. The consults shall mainly use Tromsø municipality's equipment. Most of the environmental impact in this sub-contract has been considered for driving between different places. The requirement specifications for driving consultants are therefore required to be carried out by using an ELECTRIC vehicle. Since the environmental impact of this procurement is related to driving, it will give a clearly better environmental effect to have a requirement on the use of electric vehicles, against evaluating this. In such an evaluation, there is a risk that more people will not deliver electric cars, which will have a bad environmental effect.
