The contracting authority would like to enter into a contract with architect companies who can provide architectural services for both ARK, LARK, IARK and any other relevant architectural professions that can be connected to such services. This means that the contracting authority would like tenderer(s) to provide services within all the relevant architect professions. If they do not have all the necessary professions themselves, it is a prerequisite that the tenderer can provide these professions through, or together with, other suppliers.

The contracting authority reserves the right, however, to enter into separate contracts within special professions of particularly great importance to the port, for example geotechnics and quay constructions. Separate contracts could, therefore, be signed for such areas /professions if the contracting authority finds it appropriate.

The professions and services included in the framework agreement are in the document «Tender Documentation Part II, Annex 1, Contract Basis». Relevant professional fields will typically be functions such as (but not restricted to):

— -ARK, LARK, IARK, PGL, PL, BL.

Tenderers with experience from harbour projects and with store /logistics projects will be of particular interest.

The intention is to enter into a parallel framework agreement with up to 2 companies (A and B contracts). The competition winner will normally be awarded the main assignments - the A

contract. The tenderer who is in second place will normally be awarded work with independent inspections when this is required, or when the main supplier does not have the capacity - the B contract.

The contracting authority reserves the right, however, to choose the tenderers it deems to most suitable for each assignment.

The framework agreements will be valid for two years, with an option for one and one additional year, to a maximum of 8 years (2 + 1 + 1 + 1 + 1 + 1 + 1).
