Description: De opdracht betreft het aanschaffen van circulair meubilair voor zowel het meubilair dat in de kantoren als in onderwijsomgevingen gebruikt wordt. Dit kan zowel nieuw circulair meubilair zijn, als bestaand (extern, gereviseerd) circulair meubilair. De opdracht varieert van standaard meubilair (o.a. bureaustoelen, bureaus, vergadermeubilair, kasten, belcellen etc.) tot maatwerk. Het gaat hierbij ook om nieuwe inrichtingsprojecten zoals het inrichten van eat-meet-work omgevingen. Daarnaast is advies, service op het gebied van o.a. garanties en reparaties en levensduurverlenging onderdeel van de opdracht. Er is geen verdeling te maken in jaren die een realistisch beeld geeft over de in te schatten afname per jaar. De afname van het aantal stuks meubilair en de indicatie van de totale waarde van de opdracht ligt op voorhand niet vast. Opdrachtgever heeft geen afnameverplichting.
