Skrócenie terminu składania ofert jest uzasadnione pilną potrzebą udzielenia zamówienia, wynikającą z wygaśnięcia dotychczas obowiązujących umów zawartych z wykonawcami na dostawę asortymentu objętego niniejszym postępowaniem. Brak niezwłocznego zawarcia nowych umów mógłby skutkować przerwaniem ciągłości dostaw asortymentu niezbędnego do bieżącej działalności Zamawiającego, co mogłoby prowadzić do zakłóceń w realizacji jego ustawowych i statutowych zadań.
