Reasons for the decision to award: best fulfilment of the requirements set out in the tender documents and most economically advantageous offers after evaluation of all award criteria (quality and price).

The contract is awarded to three providers (multiple award). A framework agreement will be concluded with them for 5 years. The ranking was based on the result of the evaluation of all award criteria of the present tender (sum of the achieved score from the award criteria quality and price) for the entire contract period as well as options. After awarding the contracts, the contracting authority will award individual contracts for the tendered items in competition among the three successful bidders. The published award sum per bidder refers in each case

to the quantity structure published in the tender documents (contract term 5 years, with optional extension by 2 years plus 2 further years). The cost ceiling is the highest published award sum.
