The new premises for the Art and Design University College in Møllendal in Bergen are planned with a gross area of 14 500 m². The project comprises one large building structure with workshop courtyard, workshops, project room, studio, workroom, auditorium, offices for the administration, library, video and sound studio as well as a project hall.
