Met deze voorziening kunnen gebruikers kortingen ontvangen op attracties, film, sporten, festivals, musea en theater. Daarnaast heeft de gemeente momenteel een aantal regelingen in het kindtegoed lopen die ook beschikbaar zijn voor veel gebruikers van de Stadspas. Het plan is om het gehele kindtegoed gefaseerd te gaan digitaliseren.
