Extreme urgency brought about by events unforeseeable for the contracting authority and in accordance with the strict conditions stated in the directive.

De overeenkomst betreft een opdracht waarvoor de termijnen van een openbare of niet-openbare procedure wegens dwingende spoed niet in acht konden worden genomen. Er is een dreiging van uitval van het huidige IT-systeem voor ondersteuning van het primaire proces Indicatiestelling AWBZ-zorg en daarnaast kunnen de IT-functionaliteiten niet langer geborgd worden. Het risico op de dreigende uitval van het huidige IT-systeem en het risico in (de continuïteit van) de borging worden veroorzaakt door serieuze gebreken in het huidige IT-systeem die door CIZ niet konden worden voorzien. Mocht het huidige systeem uitvallen dan komt de indicatiestelling AWBZ direct tot stilstand. Dit heeft enorme financiële consequenties en heeft een grote impact op de zorgvragenden. Daarnaast kan CIZ in dat geval niet aan haar wettelijke plicht voldoen.
