The films will focus on the award authority's various audiences, including nursery, primary and secondary school education, and teacher and nursery school teacher training. The framework agreements are related to the award authority's need for film production in the following sub-areas:

- Cartoons and Animation.

The purpose of the films will include the following:

- Focus on key issues / opportunities in the field of ICT in education;
- Increase awareness of the centre's services;
- Create motivation for using ICT in education.
