VI.3.2. Review procedure

Precise information on deadline(s) for review procedures: Calico incorporated a standstill period, following award of the contract. The period commenced on the day following award notification - 8th May - and was in accordance with The Public Contracts Regulations 2006, and all subsequent amendments and directives.

This period allowed unsuccessful tenders to seek further debriefing from Calico before the contract is entered into.

The Public Contracts Regulations 2006 (SI 2006 No 5) as amended by the Public Contract Amendment Regulations 2009 (SI. 2009 No 2992) provide for aggrieved parties who have been harmed, or at risk of harm by a breach of the rules, to take action. Any such action must be brought within 3 months of the date when the aggrieved party knew or ought reasonably have known about the alleged breach. Where a contract has not been entered into, the Court may order the setting aside of the award decision, or order the Authority to amend any document and may award damages. If the contract has been entered into, the Court may only award damages.
