Qualification requirements: the supplier must prove that they have a strong economic and financial capacity.

Documentation requirements: the supplier's financial statements (annual accounts) from the two previous years, including the auditor's report.

If the annual accounts from the last year are not completed within the tender due date for this competition, preliminary accounts for the last year shall be submitted in addition to two completed annual accounts.

Credit rating from a company certified to provide such a credit rating.

Qualification requirements: the Supplier must prove that it fulfils its obligations relating to the payment of taxes, VAT, and similar such payments under Norwegian law, or the law of the relevant State in which the supplier is registered.

For Norwegian suppliers: a certificate regarding taxes, including value added tax, issues by the tax collector's office;

For suppliers not registered in Norway: suppliers not registered in Norway must have corresponding certificates from their national authorities documenting that they have complied with the rules and regulations relating to taxes, VAT fees, duties, etc. If the authorities do not issue such certificates, the supplier shall forward a statement confirming that such taxes have been paid. The statement shall be confirmed and signed by the supplier's chief financial officer and auditor.
