II.1.4. Short description

The tender contest involves a framework agreement for architect services. The contracting authority wants a contract with tenderers who can deliver architect services for buildings (Norwegian: ARK) and landscape (Norwegian: LARK).

The contract value is estimated to be above the EEA threshold value. The estimated value is not binding for the contracting authority. The need is uncertain. Previously the contracting authority has spent approx. NOK 1.5 - 2.0 million excluding VAT per annum in the last two years. The value can be both higher and lower, and will depend on, among other things, the contracting authority's needs, activities, budgetary situation and other framework factors. Estimated annual value: NOK 1.5 million - NOK 2.0 million excluding VAT. The estimate is non binding for the contracting authority. The maximum value of the contract, including any options and anticipated price increase: NOK 9.0 million excluding VAT. See the procurement documents for further information.

Tax and VAT certificates

Tenderers must have the tax and VAT payments in order (ESPD: Part II A.e).

A certificate issued by the competent authority in the tenderer's country, confirming that the tenderer has met the obligations in regard to payment of VAT, tax and social security contributions in the country where the tenderer/contractor has its headquarters the (Norwegian certificate for Tax and VAT is combined and ordered from altinn.no, RF-1507, previously RF-1244) in accordance with the legislation in the country where the tenderer is registered. The certificate must not be more than 6 months from the deadline for tenders. The contracting authority is not allowed to request the certificate if already submitted, in accordance with the regulations, § 17-1(4). If you have submitted a tax certificate to the contracting authority and it is still valid at the time of the tender submission for this contest, you are not obliged to submit a certificate now. If this is the case, state when and to whom the certificate was previously submitted. You can, however, enclose the certificate voluntarily if you want.

Other economic and financial requirements: Economic and financial standing

Requirements regarding the tenderer's economic and financial standing: The financial capacity to fulfil the contract is required (ESPD: Part IV B.58-3).
