Tenderers must be registered in a trade index or a Register of Business Enterprises.

Norwegian Tenderers must provide an updated company register certificate.

Foreign tenderers must provide authorisation(s) for statutory registration in the country where the company is established.

III.1.2. Economic and financial standing

List and brief description of selection criteria:

1. Norwegian tenderers must enclose a tax certificate (certificate for tax, payroll tax and VAT), not older than 6 months from the deadline for receipt of tenders.

2. Tenderers must have sufficient economic and financial solidity to be able to fulfil the contractual obligations.

Minimum level(s) of standards possibly required:

1. The tax certificate can be ordered and downloaded from Altinn. If this is not possible, it can be ordered from the tax collector or the Norwegian Tax Administration. The certificate is electronically certified and is therefore not signed. This also applies for sub-suppliers with a contract value of more than NOK 500,000. Tenderers must account for any arrears.

2. Tenderers must submit extracts from the annual accounts for the last financial years, as well as the auditor's statements.

III.1.3. Technical and professional ability

List and brief description of selection criteria:

1. Experience from similar assignments.

2. Authorisations are required from a specific organisation.

3. Relevant assignments in the last 3 years.

4. Wages and working conditions

Minimum level(s) of standards possibly required:

1. State relevant experience.

2. State the transport permit number (if transport material is used that requires this)

3. State relevant assignments. Relevant assignments are in this context defined as regular (over time or on schedule) transport of temperature-controlled goods that require careful handling.

4. Documentation of wages and working conditions for employees of the service provider and sub-suppliers who will assist in fulfilling the contract. Employees at the tenderer or any sub-suppliers must not have lower wages or worse working conditions than those required by applicable national collective agreements or what is normal for the place or occupation. Cf. the regulations on wages and working conditions in public contracts established by Royal Decree on 6.2.2008, which came into force on 1.3. 2008.
