De scope van het inkooptraject betreft Europese aanbesteding Deta-Vast Constructie. Het NIC begeleidt het inkooptraject en zorgt voor de afstemming met implementatie van de overeenkomst naar de teams 'Informatiestandaarden' en 'PPIM' van Zorginstituut Nederland. De opdracht is geraamd op € 1.800.000,- (excl. BTW) over een periode van vier jaar. Hierin zijn de volgende kosten begrepen: de loonkosten inclusief de kosten die door de Opdrachtnemer worden gemaakt voor het opleidingsontwikkelingsprogramma. Deze raming is gebaseerd op vier profielen per jaar, voor een 40-urige werkweek. Waarvan de kandidaat 32 uur in de week voor ZIN werkt en 8 uur per week aan scholing besteed. Uitgaande van een uurtarieven tussen € 60,- en de € 80,- (excl. BTW). Op 1 oktober 2021 dient de overeenkomst te zijn gesloten.
