Main features of the procedure: The Contracting Authority needs cleaning machines, accessories and spare parts. These products and services shall be able to be ordered and used by the cleaning department, with delivery to all of the contracting authority's entities and addresses. The contract shall also ensure that the contracting authority has modern, environmentally friendly and updated machines. Accompanying equipment means components and products such as nalgummi, brushes, vacuum cleaner bags, air filters, batteries and other spare parts. The contracting authority reserves the right to purchase spare parts for the current machinery if the tenderer cannot offer the necessary parts within the coming contract. This ensures that the contracting authority can continue to maintain the operation and maintenance of existing equipment, even if the contract does not cover all necessary components.
