Przedmiotem zamówienia jest zakup i dostarczanie produktów leczniczych – leków, płynów infuzyjnych

i opatrunków dla potrzeb Szpitala im. Stanisława Leszczyńskiego w Katowicach w postaciach, dawkach i szacunkowych ilościach, których wykaz w podziale na Pakiety od Nr 1 do Nr 283 stanowi Załącznik Nr 2 do SIWZ – Oferta Cenowa.

Przedmiotem zamówienia jest produkt leczniczy – lek o nazwie międzynarodowej w określonej przez Zamawiającego postaci i dawce, natomiast umieszczona nazwa handlowa jest jedynie

egzemplifikacją, podaną celem usystematyzowania katalogu.

Wymagania:

1. Ilości zamawianego produktu leczniczego mogą ulec zmniejszeniu, w czasie obowiązywania umowy w zależności od bieżących potrzeb Zamawiającego związanych z udzielanymi świadczeniami zdrowotnymi i będą wynikały z bieżących zamówień bez możliwości dochodzenia roszczeń przez Wykonawcę z tytułu zmniejszenia ilości zakupionego leku.
2. Produkt leczniczy musi być dostarczony zgodnie z obowiązującymi w tym zakresie przepisami.
3. Zamawiający rozumie przez zakup i dostarczanie produktu leczniczego cykliczną dostawę produktu leczniczego na wezwanie Zamawiającego do Apteki Szpitalnej, w terminach określonych przez Zamawiającego, tj.:
