Description: I uppdrag TR.1103104 Ansk CBRN mtrl 26-28 är målet att säkerställa förmågan avseende tung sanering av främst materiel, fordon och ytor samt kollektivskyddade utrymmen. Även komplettering av förmåga till personsanering vid CBRN-grupper ingår. En inventering har gjorts huruvida befintliga ramavtal för olika modeller av containers vore tillämplig. I inget fall föreligger dessa förutsättningar varför en ny upphandling behöver göras. Då upphandlingen avser en militär variant av container är LUFS tillämpligt och genom ett förhandlat förfarande i ett steg. Anskaffningen avser 15 st (+ 15 st i option att vid behov lösa ut styckvis inom en 5-

årsperiod från leveranskontraktets tecknande) och är ett komplement till de 6 saneringscontainers som är i bruk idag. I detta leveranskontrakt ingår ILS, en brukarutbildning och en teknikerutbildning samt CLS. Även reservdelar är inkluderade. Aktuell anskaffning utgör en av fyra systemdelar som ska anskaffas inom projektet Tung sanering varvid övriga delar anskaffas separat och genom avrop från andra tillämpliga ramavtal.
