Project Management for a New Primary School in Sykkylven

#### **II.1.4. Short description**

Sykkylven municipality call for tenders for project management and execution of the project "New Primary school in the central areas". The new school must replace the current 3 primary schools, Ullavik school, Aure school and Vik school. All schools are situated in the central areas of Aure. The new school shall be a 3-parallel primary school with a capacity between 336 and 525 pupils. The school is currently designed to include a multi-user hall and a culture school and has a gross area of approx. 8,200 m<sup>2</sup>.

The zoning plans are subject to preparation and are expected to be completed in 2019.

Archaeological registrations are executed and county reports from the county are ready.

Automatic protected culture relics were not detected. Ground surveys and flood zone mapping are also executed.
