The contract includes the procurement of wood, building materials, painting products, wall and floor coverings. The county has a continual need for efficient ordering and delivery processes to several locations and storage points. The framework agreement shall therefore facilitate a practical and secure supply line with an appropriate assortment, stable delivery quality and the necessary documentation. At the same time it is important that the tenderer can support the county's requirements for quality, environment and traceability in the deliveries.

Main features of the procedure: The assignment is for the establishment of a framework agreement for the delivery of building materials to Trøndelag county. The agreement shall cover a broad need for standard building materials that are used in operation, construction, maintenance and renovation projects. The framework agreement shall i.a. include timber, plates and mouldings, paint and surface products, glue and joint masses, insulation as well as a vapour barrier and sheathing, in addition to fasteners, fittings and tool consumables. The delivery shall support a digital ordering system (e-commerce), and include distribution to several delivery addresses, including options for urgent deliveries in accordance with acute needs. Furthermore, the contract shall support appropriate assortment management, including handling replacement products, as well as safeguarding overall needs connected to product documentation, environmental information and traceability for relevant goods.
