A new nursery with 6 departments shall be engineered and constructed in Sponstugrenda 27. The existing buildings at the site will be demolished during autumn 2016. The assignment also includes the development of the outdoor area. The property developer must establish an engineering design group that safeguard all required special fields for this assignment.

The assignment shall be executed in 3 stages:

Stage 1 Preliminary project.

Stage 2: Detailed engineering design, construction, implementation and commissioning.

Stage 3: Test operation, take-over and complaint period.

Ground surveys have not been carried out on the site. The necessary surveys must be carried out at the tenderer's expense.
