ILM consists of at least the following services:

- Scheduled A- and C-check including material and parts according to the low utilization program (see Annex 5 with the aircraft utilization aspects)
- On Site Assistance including necessary tooling and equipment at the home base Eindhoven Airport and any other location worldwide including 'Out of Area' on a 24 hours notice (Eindhoven Air Base) and 48 hours notice (within Europe) and 72 hours notice (remaining locations)
- Drop in maintenance at Contractors facility on a 24/7/365 basis
- Component Maintenance
- As from 1.5.2014 Contractor should be able to reproduce the workpackage (jobcards) under reference of the RNLAf Aircraft Maintenance Program (AMP)
- Maintenance Engineering under EASA 145 approval or equivalent
