— an average annual turnover of minimum 50 000 000 NOK in the last 3 financial years,

— tenderers must have an equity ratio of at least 10 %.

III.1.3. Technical and professional ability

List and brief description of selection criteria:

Tenderers must have sufficient experience of a relevant nature and complexity for the following works:

1) The main disciplines included in the assignment include: operation and maintenance of roads;

2) The following sub-assignments are of significant importance for the contract work:

— winter operations,

— clearing traffic areas/traffic objects,

— construction notification and traffic management,

— operation and maintenance of road objects.

Tenderers are required to refer to references for relevant contracts that they themselves have carried out in a satisfactory manner.

The contract must be sufficiently staffed and the tenderer must have the capacity and ability to handle unforeseen circumstances in the contract.

Technical and professional competence and relevant experience is required of the key personnel who will be involved in the assignment.

The tenderers shall have a system that shows that they work proactively as regards safety, health and the working environment (SHA), with relevance for equivalent works as those included in this competition. The system shall be subject to periodic review.

Tenderers and their central contract assistants ought to have an average H1 value lower than 15 for the previous 3 years.

Tenderers must be certified in accordance with ISO 14001 (2015), EMAS (EU Eco-Management and Audit Scheme for environmental management), or eco-lighthouse.

Tenderers must be certified in accordance with ISO 9001 (2015), or for the part of the organisation that has contractual obligations to the builder; establish, maintain and, when necessary, update a quality system that has equivalent requirements to those in ISO 9001 (2015).

0702 Vestfold west has been announced and cancelled twice. Only one tender was received in the last contest. The contest was cancelled due to a lack of sufficient subsidies to enter into a contract with the tenderer. A decision has been made to split up 0702 Vestfold west into 3 smaller contracts, 0702 Vestfold south, 0703 Vestfold north, and 0704 Vestfold national roads. The contract requires competence, staff and equipment suitable for the contract area. We can sign a contract in early July by using the deadlines in the PPR §20-2 (3). This will give the chosen tenderer time to mobilise the resources that must be in place by 1.9.2019. Contract 0703 Vestfold north comprises county roads to the west of the E18, in Vestfold north's previous operational contract area. The contract requires competence, staff and equipment suitable for the contract area. We can sign a contract in early July by using the deadlines in the PPR §20-2 (3). This gives the chosen tenderer time to mobilise the resources that must be in place by 1.9.2019.
