Justification for direct award: The contract can be provided only by a particular economic operator because of an absence of competition for technical reasons

Other justification: Raseljene osobe iz Ukrajine u Republici Hrvatskoj su trenutno smještene u kolektivnim smještajima. Kolektivni smještaji ugovoreni su putem procesa javne nabave, te je s ponuditeljima sklopljen Okvirni sporazum za uslugu smještaja sa punim pansionom. Obzirom kako je privremena zaštita produžena još godinu dana, postoji potreba za sklapanjem Ugovora o pružanju usluga smještaja sa punim pansionom sa postojećim potpisnicima Okvirnih sporazuma. Trenutni kolektivni smještaji imaju potpisane Okvirne sporazume već više od dvije godine te u Okvirnim sporazumima (članak 2.) predviđena je opcija „produljenja ovisno o potrebama Naručitelja“.
