- that a change of contractor, for evaluations of opportunity and convenience, is impractical for economic and technical reasons and would result in the suspension of the school service and the operation of the departments located there;
- of art. 1 of the contract No 10,607 of the Rep. On 10 January 2017 stipulated by the General Command of the Carabinieri with the R.I. S.P.A. of Trepuzzi (LE), which expressly provides the right of the CEO, at the end of the twelfth rental month, to decide for which blocks to continue the rental at a reduced rent of 30 %.
