The Molecular Biology and Genomics Unit (MBG) of the Institute for Health and Consumer Protection (IHCP), Joint Research Centre (JRC) of the European Commission is launching a call for tender for the acquisition and maintenance of a droplet digital PCR system.

The MBG Unit of the JRC/Ispra is performing digital real time PCR analysis in order to meet legal obligations of the European Union Reference Laboratory for GM Food and Feed defined in Regulations (EC) 1829/2003, (EC) 882/2004, and (EC) 619/2011 (LLP Regulation).

— stage 1: supply, delivery, installation, testing, on-site training and provision of documentation of the equipment as specified below within 3 months from the date of the last signature of the contract + 24 months' warranty from the date of acceptance of the supply through the certificate of conformity,

— stage 2: after the end of the warranty, maintenance of the equipment for 12 months, renewable up to 2 times (for a total maximum maintenance period of 36 months).

Should they be awarded the contract, the members of the consortium may provide the lead member with an official power of attorney. If the contractor is a grouping or consortium of 2 or more persons, all such persons shall be jointly and severally liable to the Commission for the fulfilment of the terms and conditions of the contract. Such persons shall designate one of them to act as leader with full authority to bind the grouping or the consortium and each of its members. The composition and constitution of the grouping or consortium, and the allocation of the scope of tasks amongst the members, shall not be altered without the prior written consent of the Commission which can be withheld at discretion.
