All quantities are estimates and will include various sizes and in addition these will be for a variety of Regiments. The requirement to include 3200 Kilts, 260 various Plaids, 480 Scarves, 31 Shawls, 2800 pairs of Trews, 2500 pairs of gaitors, 60 pairs of spats, 5500 pairs of stockings/hose over the 4 year period.
