Other justification: The number of patients requiring cataract surgery is however extremely high, to the extent that the service being provided at Mater Dei Hospital is not keeping up with the demands of cataract procedures that need to be completed. As a result of this, it has been decided at that this service for cataract replacement surgery will need to expand its services to the Ċensu Moran Regional Hub. To ensure parity in clinical services, patient outcomes, and institutional reputation, it is proposed that the equipment installed at the Ċensu Moran Regional Hub will be the same as that that is being provided by Mater Dei Hospital.
