The users have psychological and/or physical disabilities with needs that mean that the use of public transport is inappropriate. The users' disabilities vary and some users depend on an attendant during transport. To the degree that an attendant is relevant, the attendant will be employed at the contracting authority or will be a relative of the user.
