Justification for direct award: The contract can be provided only by a particular economic operator because of an absence of competition for technical reasons

Other justification: Hankemenetlus viidi läbi vastavalt RHS § 49 lõike 1 punktile 2, sest, sest hankelepingu saab sõlmida ainult ühe ettevõtjaga konkurentsi puudumisel tehnilistel põhjustel

ja ainuõiguste tõttu. Hankija vajab seadet teravilja ohete veevahetuse ja fluorestsentsi kiireks mõõtmiseks. Turul on ainult üks seade, mis on ehitatud spetsiaalselt okaste, kitsaste lehtede ja teiste sarnaste taimeorganite kiireks mõõtmiseks – LI-COR LI-600N poromeeter /fluoromeeter. Antud seadme mõõtmistulemused peavad olema ristkasutatavad juba olemasolevate seadmetega LI-600 ja LI-600N mõõdetavate tulemustega (seade peab kasutama täpselt sama mõõtmispõhimõtet ja tehnikat). Konkreetne seade on vajalik, et eri taimeosadelt mõõdetud andmed oleksid kasutatavad ühtses andmemassis koos teiste seadmetega mõõdetud tulemustega. Hankija on hinnanud sobivaks seadmeks LI-COR LI-600N poromeeter/fluoromeeter, mida Eestis müüb ainumüügiõigusega Est-Doma OÜ.
