Description: Statsbygg requests tenders for a contract for the care and maintenance of green areas for properties in Ørsta and Volda. The contract is planned to start 1 July 2026.

Main features of the procedure: The aim of the contract is to ensure continual seasonal care. The green areas shall be maintained and monitored, so that the properties' condition does not deteriorate and the values are maintained. The care assignments include i.a. lawn cutting, robotic lawn cutting, edge pruning along bed and foot paths, removing leaves, sweeping and flushing, pruning bushes and trees, and maintenance of gravel courts. Minor excavation works can also be ordered. See the attached tender invitation for further details on the maintenance tasks.
