The Ministry of Culture will enter into a contract with the applicant who has the best plans for nationwide news bulletins based on the tenderer's central news editors, programmes for children and youths, as well as premier viewings of Norwegian films and TV dramas, see chapter 7. The applicant's plans for this content will be included in the public service broadcasting assignment. See the notice documentation for further details.
