Description: Troms county invites tenderers to a competition for framework agreements for transport services for facilitated school transport in Kvæfjord, Målselv and Lyngen municipalities. The assignment is divided into 6 contract areas, as stated in the Procedure Rules point 1. The contracting authority will enter into separate contracts for each contract area. The contracts will be valid from 01.08.2026. End date varies between contract areas. The contracting authority has a unilateral option for up to one year extension. Tenderers are encouraged to go through the tender documentation carefully and get in the competition rules. If the tender documentation appears unclear, tenderers are encouraged to ask questions to the contracting authority.

Main features of the procedure: The assignment is for carrying out transport services in connection with facilitated school transport, i.e. transport of pupils with the right to transport in accordance with the Education Act.
