This contract effectively manages the municipal waste collected by the Council. The Contract will deal with up to 20,000 tonnes per annum. This is an indicative tonnage and does not constitute a guaranteed tonnage. Contractors are requested to submit fixed prices based on the potential 18 month term of contract. Estimated value (excl VAT) (including landfill tax) 2 500 000 GBP over the potential 18 month contract.
