Tarjouspyynnön kohteena ovat poliisin tilaamat vainajien päivystyskuljetukset Etelä-Karjalan alueella (Parikkala, Rautjärvi, Ruokolahti, Imatra, Lappeenranta, Lemi, Luumäki, Savitaipale ja Taipalsaari). Hankinnan kohteena ovat:

1. Päivystyskuljetukset, joissa vainaja siirretään sijaintipaikalta vainajien säilytystilaan tai suoraan ruumiinavauspaikkaan. Vuonna 2018 päivystyskuljetuksia on ollut 314 kpl vuodessa. Kuljetuksen tulee sisältää poliisin tai terveydenhuollon toimista johtuva odotusaika. Vuonna 2018 odotusta sisältäviä kuljetuksia on ollut 39 kpl, joista 32 kpl on ollut kestoaltaan 0,5 h. Odotusaikojen kesto on ollut n. 0,5-1,5h. Uudella sopimuskaudella kuljettaja voi jättää vainajan terveydenhuoltohenkilöstön vastuulle tapauksessa, jossa vainaja jää välisäilytyspaikkaan. Edellisen sopimuskauden kuljetusmäärät kuvastavat arvoitua hankinnan ennakoitua hankintavolyymia, joka voi poiketa toteutuneesta.
