The procurement shall exclude from competitive tendering any tenders that fail to correspond to the call for tenders or to the terms and conditions of the tendering procedure or if the tenderer does not meet the suitability requirements. If the information or documents in a tender are incomplete or incorrect in immaterial respects, or if some documents or information are missing that are not used to assess compliance with the call for tenders or the fulfillment of the tender suitability requirements or to compare tender, the contracting entity may request the tenderer to submit, add, clarify or supplement the information or documents within the time limit imposed by procurement entity.
