The range of vehicles covered will be from light goods vehicles to maximum weigh heavy goods vehicles. The cables will be used by enforcement officers to underpin prohibitions placed on these vehicle types.

The device (cable) is intended to be connected between a component of a vehicle that is used to transmit motion (eg wheel) and a non-moving part (eg chassis component) via a heavy duty padlock/locking device to discourage the movement of the vehicle. However, when fitment in this way is impractical alternative methods are acceptable.

- (e) Where the products or services to be supplied are complex or, exceptionally, are required for a special purpose, a check carried out by the contracting authorities or on their behalf by a competent official body of the country in which the supplier or service provider is established, subject to that body's agreement, on the production capacities of the supplier or the technical capacity of the service provider and, if necessary, on the means of study and research which are available to it and the quality control measures it will operate.
