**II.1.4. Short description**

The contest concerns a framework agreement for the delivery of packaging machines with equipment, servicing of packaging machines and consumables/packaging for these in connection with food production.

The tender contest primarily concerns deliveries to commercial kitchens in the municipalities. Schools, kindergartens and other organisations are not covered by the contest.

Tax and VAT certificates
