— Operators must be available to undergo Company review of waste disposal facilities.

(Company's Third Party Waste Stewardship process) which includes, but not limited to, a questionnaire on processes and procedures, financial status, proof of permits and regulatory compliance as well as a site visit;

— operators must have suitable resources available to meet demanding schedule, requirements to work as and when required by Company, this may include responses at short notice,

— operators must be permitted to accept hazardous and non hazardous wastes including, but not limited to (01 05).
