- 3) Minimum five references of PEXcable deliveries within EC of min 72,5 kV according to IEC 60840. References with AL-Shield are desired, but is not a requirement. Suppliers with this reference are preferred.
- 4) References of delivery of PEXcable with two colour outer shield for the purpose of damage control
- 4) Certification under ISO 9001, ISO 14001 and QHSAS 18001 (to be included). If not certified the applicant must include its own quality, safety and environment manuals.
- 6) The applicant Corporate Social Responsibility (CSR) policy (to be included).
