Service providers shall include option prices for future furnishings/fittings of extension(s). Site: The church shall be built on a site close to the old church in the centre of Ålgård. The site adjoins the cemetery. The excavation work is planned to start up in the Summer of 2013, with completion of the church building during 2015. Norconsult is acting as construction manager. The work shall be implemented as enterprises controlled by construction manager (21 enterprises). This contract comprises wood work, enclosed stage, including exterior cladding.
