Bij een wissel van leverancier dient het personeel te worden opgeleid, moeten logistieke processen hertekend worden, moet voorraadbeheer aangepast worden en moeten gebruikers gewend worden aan nieuwe producten, dit zijn allemaal investeringen die zich pas op langere termijn terugbetalen. Te veelvuldige wissels geven risico op fouten in gebruik en extra belasting voor het personeel, continuïteit is dus een legitiem algemeen belang. Ook de plaatsingsprocedure betreft een zwaar traject dat niet om de 4 jaar kan worden herhaald zonder disproportionele lasten.
