Explanation:

Given the spread of Covid-19 pandemic in the UK (and Worldwide), research remains ongoing and constantly evolving to find effective ways of curtailing the virus. Azithromycin and Dexamethasone are medicinal products that are being investigated for the treatment of Covid-19 and need to be trialled before the treatments can be rolled out more widely for Covid-19 patients in sufficient quantities. For the safety and assurance of all concerned, DHSC observes a detailed governance process for clinical trials which was followed. On completion of this process, DHSC had to move very quickly to secure the medicinal products in order to complete the trials as soon as possible. This is in order that where the trials are successful it could purchase substantive quantities of the medicinal products to be used for the treatment of Covid-19.

The procurement exercise was commenced by the contracting authority on 3 April 2020 and an invitation to negotiate and submit an offer was issued to suppliers in this regard on 7 April 2020.

While the procurement was not specifically divided into lots, the contracting authority awarded a number of contract simultaneously in order to meet its requirement.
