Anskaffelsesforskriften - Due to questions of both a professional and legal nature that was received just before the deadline for asking questions expired, we postpone the tender deadline until 7 May 2026. The new deadline for questions and answers is set to 21 April 2026. The competition terms are updated (2722 Competition Provisions Rev. 1).

Anskaffelsesforskriften - Sub-contracts 3 and 4 have been merged to Sub-contract 3 so that Immunoglobulins for extravascular administration (SCIG) are in one and the same group.

2.1.6. Grounds for exclusion
