Precise information on deadline(s) for review procedures:

Within two months of the notification to the plaintiff or, in absence thereof, of the day on which it came to the knowledge of the plaintiff an appeal has to be lodged with the General Court. A complaint made to the European Ombudsman neither suspends this period nor opens a new period for lodging appeals. Time-limits are extended on account of distance for a fixed period of 10 days regardless of the location or usual residence of the person concerned.
