The film package shall be a targeted tool in the work of profiling Norwegian film art and film culture at important cultural film arenas abroad and thereby contribute to the development of broad knowledge and expertise and international recognition for Norwegian films. The package shall also contribute to strengthening the possibilities of a sustainable Norwegian film industry.
