Due to the nature of the services required and their place of delivery, the ETF is seeking a company, which will ensure a strong local base in Albania and with the staff appropriate for achieving the scope of the contract.

The selected service provider will provide upon request the 3 main types of services which may also be closely linked:

service A: organisation of project meetings such as workshops, seminars, conferences, study visits in the field of ETF work;

service B: provision of a limited set of event-related services;

service C: support to ETF networking activities in Albania.

Given the subject of the contract, participation in this call for tender is open to all natural and legal persons that are established (domicile or headquarters respectively) in the EU, the ETF partner countries (for the full list see the tender dossier or visit <http://www.etf.europa.eu>), Liechtenstein and Norway.
