Bomiva, afd. 4 — Vestervænget, Skive (herefter »Bygherren«) står for at skulle renovere 236 lejligheder fordelt på 10 etageblokke samt 11 dobbelthuse beliggende Vestervænget i Skive. Renoveringsarbejderne forventes udført i perioden april 2014-april 2018. I henhold til godkendt Skema A er den samlede anskaffelsessum for renoveringsarbejderne 233 065 872 DKK ekskl. moms, heraf vedrører 197 589 978 DKK ekskl. moms støttede arbejder og 35 475 872 DKK ekskl. moms ustøttede arbejder.

Den udbudte tjenesteydelse består i at finansiere renoveringen ved at yde:

- 1 byggelån på 233 065 872 DKK
- 1 støttet realkreditlån på 197 589 976 DKK
